


Here is the brief for Friday 9 April 2021.

As a reminder, this rate is arrived at by dividing the number of positive tests in the past 7 days by the number of tests carried out in the past 7 days. Repeat tests are included in both categories, whereas the figures we show here only record new tests. World Hand Hygiene Day – 5 May - Let's get those gloves off! The point of care delivery is the place our patients, our workforce and environmental surroundings come together, where we are enabling the provision of direct care and treatment. The overuse of gloves increases the risk of infection to patients at the point of care delivery, where the 5 moments of hand hygiene become most critical. Overuse of gloves can prevent hand decontamination opportunities being undertaken, is inappropriate, and gives false assurance to the wearer. The use of gloves for many tasks is unnecessary.

So, as a current healthcare worker, such as a domestic, a porter, or one of our direct care providers (nurse, medic, AHP) are you:

- Only ever using gloves when absolutely necessary?
- Undertaking hand hygiene at the right times?
- Have you started using more gloves than previously, or double gloving due to COVID-19?

HealthRoster system upgrade As highlighted in previous briefs, HealthRoster 11 will go live next week. The link to access HealthRoster 11 will be shared with you by email in the latter half of the week. The link will also be available on the eRostering intranet page, and as a quick link in your intranet browser.

HealthRoster 11 is a user friendly, intuitive facelift to the system, but the actual functionality has not been changed. Many users will find that they are able to make a seamless transition to the upgraded system without referring to any training materials. However, we will have a set of support materials available on the eRostering intranet page. When you log in to HealthRoster 11 for the first time, there will also be a short in-system tour highlighting basic changes to the navigation. You will be able to view this tour as many times as you like. We strongly recommend that all users view the short videos available now on the dedicated [v11 intranet page](#) (networked devices only) prior to logging in to HealthRoster 11.
